Figure Skating: The Valley East Skating Club provides qualified group instruction for the Novice and Junior recreational skating programs. Any skaters wishing additional private instruction may engage the services of a certified and registered Skate Canada coach. At the Junior, Intermediate, and Senior levels the Club does not provide group instruction, and it is the responsibility of a skater enrolled in any of these programs to employ a certified and registered Skate Canada coach. Such an arrangement constitutes a private contract between the Skater and the Coach. Although the Club has no direct involvement in these contracts, the Club may, at its discretion, suspend the skating privileges of any skater having delinquent account with a Coach until such time as the account is settled.

Policies:

The Valley East Skating Club reserves the right to cancel any session prior to the commencement of the session, and any registration fees which have been paid will be refunded in full.

There will be absolutely NO refund of fees after the commencement of the session for which the applicant has registered. The ONLY exceptions will be for reasons of health (to be verified by a written document from a licensed medical doctor), or the relocation of the applicant's residence outside of the boundaries of the former Town of Valley East, verified to the satisfaction of the Board of Directors of the Club. The amount of any refund will be based upon a formula which shall, from time to time, be determined by the Club. An administration fee will be charged for all refunds granted.

All accounts (owed to the Club, a coach, dance partner, etc.) must be PAID IN FULL prior to a skater receiving permission to try a test.

Parental Or Guardian supervision is required at all times. YOU are responsible for your child.

Times and dates are subject to change.

As a figure skater, I commit to follow the following rules while on the ice:

- 1 No Standing around
- 2 No standing in groups on the ice
- 3 No 'tag' games
- 4 No sliding on the ice
- 5 No shadowing other skaters while they do their solos
- 6 Skater must participate in any group lessons/activities going on unless in a private lesson (ie: if dance is being played, the skaters should be practicing their dance)
- 7 Skaters must be aware of and avoid another skater doing a solo at all times
- 8 Drinking water should not turn into chatting on the ice.
- 9 Bullying in any form will not be tolerated and will result in disciplinary action and possible suspension
